78th ANNUAL CONVENTION

The Pacific Coast Section of NSA and the Pacific Coast Grower's Association hosted the 78th Annual Joint Meeting of NSA and SINA in Seattle, Washington on June 22-26. Two hundred eighty-nine people, including 166 NSA members attended the conference, which was held at the Crowne Plaza Holiday Inn. Participation in the technical sessions was among the best in recent years. According to Program Chairman John Manzi Carolina Marine Resources Research Institute), concurrent sessions were required to handle nearly 100 presentations. Contributed papers came from 17 states, Canada, Australia, and Puerto Rico. Two special symposia recruitment of commercially important decapods and depuration in North America. Social highlights of the meeting included visit to the Coast Oyster Company Hatchery and a multi-course Chinese dinner organized by Ken Chew and attended by a large fraction of the conventioneers.

The Excecutive Committee of NSA passed a resolution dedicating this 78th Meeting of NSA to the memory and work of the late Eugene Petrovits.

The Thurlow C. Nelson Award for the best paper by investigator was presented to Stephen T. Tettlebach of Marine Research Laboratory, University of Connecticut for paper entitled "Crabs vs. Bay Scallops: Effects of predator prey size on feeding rates and predatory behavior." mention went to Jonathan Davis and Sandra Downing, both of the School of Fisheries, University of Washington, for their work on triploidy in oysters. Congratulations to all three.

JOURNAL OF SHELLFISH RESEARCH

Volumes 4 (1) and 4 (2) of JSR were mailed in early September and should be in members hands by now. If you have not received your copies, please contact Secretary/Treasurer Scott Siddall (Marine Sciences Research Center, SUNY, Stony Brook, NY 11794; (516) 246-8678). Volume 5 (1) is at the printers and should be out before the end of the year.

A major topic of discussion at both the NSA EXCOM and Business Meetings was the status of JSR. Retiring Editor Roger Mann reported at the Business Meeting held Tuesday June 24, that the Journal was two years behind its publication schedule. He said that every effort should be made over the coming year to put the Journal back on schedule and that if this could not be done, the Society should cease trying to publish it. Business Manager, Ed Cake, accepted much of the responsibility for the delays, which have been aggravated by illness of the typesetter and a hurricane that disrupted work at the Gulf Coast Research Laboratory where Ed is located.

At the Executive Committee Meeting held Sunday, June 22, Roger stated that the number of manuscripts being submitted to the Journal was lower than in previous years, but fawer were of unacceptable quality. He further noted that the review process usually takes three months and concluded that papers must be published six to nine months after receipt.

The Executive Committee appointed Bob Hillman (Battelle Northeast) to temporarily succeed Roger as Editor. Bob stated that he planned to restructure the JSR review process to include an Editorial Advisory Board. He also reported that Sandra Shumway (Bigelow Laboratory for Ocean Sciences) had agreed to assist him and to eventually take over as Editor of the Journal. Mike Castagna (Virginia Institute of Marine Science) was named chairman of the Publications Committee. Ed Cake, Mel Carriker, Bob Hillman, and Roger Mann will also serve on the committee.

Manuscripts for Volume 6 (1) are in review. Present plans are to use a "full-service" publishing company to handle the *Journal* beginning with Volume 6. This company will accept reviewed manuscripts and take care of all further matters including galley and page proofs, printing and mailing, and reprint and back order requests.

SUMMARY OF THE 1986 EXECUTIVE COMMITTEE (EXCOM) MEETING

The NSA EXCOM Meeting was held Sunday afternoon, June 22. Secretary- Treasurer Scott Siddall summarized the financial status of the Association as of the fiscal year ending May 31, 1986:

Scott reported that more than 300 members had not yet paid their dues for 1986, which resulted in lower-than-expected revenues so far this year. Audit-Budget-Finance Chairman George Abbe presented the proposed budet for June 1, 1986- May 31, 1987 (see next page). It was unanimously approved by the EXCOM. The Committee also concluded that informal "audits" or reviews of the Association's books, which have traditionally been done by a CPA at significant cost, can be done satisfactorily by the Audit-Budget-Finance Committee. This review process will begin in 1987 when a new Secretary-Treasurer takes office.

Honorary Membership Committee Chairman Bob Malouf reported that neither the David Wallace Award nor an Honored Life Membership would be given this year. Eighty-three new members were approved by the EXCOM (see list at end of Newsletter). Scott Siddall reported that 24 members had retired or been dropped from the rolls for nonpayment of dues during the year. (An additional 30 members were recruited during registration at the Meeting).

The matter of eligibility for the Nelson Award was discussed. Last year's Award Committee had recommended that single-authorship be a criterion for papers considered for the Award. The EXCOM concluded that papers with multiple authors should be eligible and that some consistent guidelines for eligibility be included in the new Constitution/By-Laws.

Ken Chew and John Manzi reported on the Aquaculture '86 Meeting held in Reno in January. There were 1,700 registrants at the meeting and \$74,000 in profits were divided among the sponsoring organizations according to the number of their registrants. NSA was an affiliate sponsor of the '86 meeting but expects to be a full sponsor of Aquaculture '89. The EXCOM endorsed Los Angeles as the site of the '89 meeting.

Ed Cake, Chairman of the Nominating Committee announced that about 200 ballots had been received in the election for Association Officers. The results were

SUMMARY OF THE 1986 ANNUAL BUSINESS MEETING

President Bob Hillman called the meeting to order with a quorum of 42 members present. He thanked those NSA members who had helped run the Association over the past year and especially those who had organized the Seattle meeting. A resolution was unanimously adopted thanking organizers for their dedicated efforts in making the convention a resounding success. Secretary-Treasurer Scott Siddall and Audit-Budget-Finance Committee Chairman George Abbe reviewed the financial status of NSA (see EXCOM MEETING SUMMARY). Both the Treasurer's report and the 1986-87 proposed budget were approved. Scott noted that NSA currently has 722 active members.

John Manzi discussed arrangements for the 1987 meeting, which will be held in Halifax, Nova Scotia. John noted that SINA had decided not to meet outside of the country in 1987. This means that NSA will be conducting the meeting on its own, including the handling of registration, which has previously been done by SINA. Both SINA and its umbrella organization NFI (National Fisheries Institute) are looking forward to future joint meeting with NSA when possible. Several sites on the Gulf Coast, including New Orleans, Biloxi, and Corpus Christi, are being considered for the 1988 meeting. John also pointed out that NSA's participation in the Aquaculture '89 Meeting could be a significant source of revenue for the Association (see EXCOM SUMMARY).

President Hillman reported on the progress made in revising the Association's Constitution and By-Laws. The original goal of completing this task before the 1986 meeting could not be met as the documents required major revision; however, the committee hopes to complete the task well in advance of the 1987 meeting.

Bob then turned over the gavel to incoming President Robert Malouf who, in turn, presented Bob Hillman with a plaque honoring his service to the Association.
